

## Adelaide Hockey Club – THE POD

Each year the Adelaide Hockey Club invites all members and others in the community with ties to the Club to participate in a program, affectionately named "THE POD". Membership of THE POD provides access to certain benefits over and above those available to playing members of the Club while also supporting long term sponsorship of the Club and its financial sustainability.

Membership of THE POD is optional but membership allows members to contribute toward the Club's ongoing success through the provision of funds towards the ongoing development of facilities and athletes at Adelaide Hockey Club. As a registered fundraising partner of the Australian Sports Foundation, a portion of THE POD membership fee is tax deductible for the donor. In addition to contributing to the Club's financial security and growth, members are also offered exclusive rewards for their support.

Membership fees for 2023 are \$250, of which \$200 is tax deductible.
